BASIC INFORMATION

All plumbing and sewer work being done in the Village of Bratenahl shall conform to the Amended Version of the Ohio Plumbing Code of current publication and accepted engineering practices. Fee schedules are subject to additional charges for plumbing/sewer appurtenances. Revised 6/93. A rough and final plumbing/sewer inspection is required on all plumbing/sewer work. The fees for a plumbing/sewer inspection are \$35.00 each and shall be in addition to the base fee plus line item fees. Additional inspections due to faulty/shoddy workmanship, and/or violations shall be an additional fee of \$50.00 for each occurrence. The Building Commissioner reserves the right to issue a "STOP ORDER" at any time he feels the work does not conform to proper standards and/or is in violation of Local, State or Federal Laws. Repeated violations will result in license revocation.
