ORDINANCE NO: 4190

INTRODUCED BY:

AN ORDINANCE AMENDING SECTION 925.09 OF THE STREETS AND PUBLIC SERVICES CODE ENTITLED "BRATENAHL VILLAGE DOG PARK" AND DECLARING AN EMERGENCY

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Bratenahl, State of Ohio, that:

SECTION 1. Section 925.09 of the Streets and Public Services Code be amended to read as follows:

"925.09 BRATENAHL VILLAGE DOG PARK."

- (a) The dog park hours are 8:00 a.m. to dusk dark.
- (b) All dogs must be leashed when not within the fence of the dog park.
- (c) Each dog must have a current dog license and rabies tag displayed on its collar and up to date on all vaccines as required by the Board of Health.
- (d) Dog waste must be properly disposed of immediately.
- (e) Handlers must fill in holes dug by their dogs.
- (f) No more than three dogs per handler.
- (g) Sick Dogs that are sick, injured, in heat or a dog that has been declared vicious are not permitted in the dog park.
- (h) A dog that becomes aggressive must be removed from the dog park immediately.
- (i) All dog bites must be reported to the Bratenahl Police immediately (216-681-1234); call 911 for severe bites.
- (j) Any dog under the age of four months is not permitted in the Dog Park.
- (k) Children aged 6 or under are prohibited and children ages 7-16 must be under adult supervision at all times.
- (I) To prevent aggressive canine behavior, human and dog food of any kind are prohibited.

- (m) Dogs must be leashed when outside the fenced-in area. A leash must be accessible for each dog at all times.
- (n) Dogs must not be unattended or out of sight.
- (o) Dog Owners are solely responsible for all damage or injury inflicted by their dog(s).
- (p) Any person entering the Dog Park assumes the risk of any harm, injury to person or property, or negligence of any other person, handler, or dog owner in or at the Dog Park.
- (q) Failure to comply with these Rules and Regulations or any applicable Village ordinance will result in expulsion from the Dog Park and may be subject to citation and prosecution as set forth in Section 925.99.

SECTION 2. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, safety, health and welfare of the inhabitants of the Village of Bratenahl by reason of the immediate necessity to enact and add Section 925.09 of the Codified Ordinances of the Village of Bratenahl. Wherefore, this Ordinance shall be in full force and effect immediately after its passage.

ORDINANCE NO. 4192

INTRODUCED BY:

AN ORDINANCE AMENDING CHAPTER 509 TITLED "DISORDERLY CONDUCT AND PEACE DISTURBANCE" BY ENACTING AND ADDING SECTION 509.11 OF THE GENERAL OFFENSES CODE TO REGULATE HOURS FOR CONSTRUCTION OR REPAIR OF BUILDINGS AND USE OF HEAVY EQUIPMENT AND DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the Village of Bratenahl, State of Ohio, that:

SECTION 1. Effective upon the date of adoption of this Ordinance, Chapter 509 of the General Offenses Code be amended by enacting and adding Section 509.11 to read as follows:

<u>"509.11 REGULATION OF HOURS FOR CONSTRUCTION OR REPAIR OF BUILDINGS</u> AND USE OF HEAVY DUTY EQUIPMENT.

(a) No person, firm or corporation shall operate any heavy duty commercial earth moving, ditch digging, grading, loading or excavating equipment; or compressed air hammer, drill, jack or other similar construction or road building equipment; or operate dump trucks, carry-alls or tractor trailers on private property between the hours of 6:00 p.m. and 7:00 a.m., or on Saturdays, Sundays, Christmas, New Year's Day, Memorial Day, Fourth of July, Labor Day or Thanksgiving Day.

However, in case of flood, fire or other natural catastrophe, or in case of urgent necessity for the protection of the public peace, health or safety, the Mayor may permit the use or operation of such vehicles or equipment between such hours or on such days.

(b) Whoever violates this section is guilty of a minor misdemeanor."

SECTION 2. This Ordinance is hereby declared to be an emergency measure and necessary for the immediate preservation of the public peace, safety, health and welfare of the Village and for the further reason that the same relates to the need to update the code; therefore, this Ordinance shall take effect and be in force immediately upon its passage and approval by the Mayor.

WHEREAS, ReadyNotify is a mass notification system used by Cuyahoga County and participating municipalities to issue notifications to the public and internal employees; and

WHEREAS, ReadyNotify delivers messages to residents by telephone, cellular phone, text message, electronic mail, etc.; and

WHEREAS, ReadyNotify will be primarily used for emergency notifications, when prompt and accurate information is essential for immediate safety.

BE IT RESOLVED by the Council of the Village of Bratenahl, County of Cuyahoga, and State of Ohio, that:

SECTION 1. The Mayor be, and he hereby is, authorized to enter into a Memorandum of Understanding with Cuyahoga County for access to the County's Mass Notification System, a copy of which Memorandum of Understanding is attached hereto as Exhibit "A" and incorporated herein fully as if by reference.

SECTION 2. The Council declares this Resolution to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is the need for access to the County's system, therefore, said Resolution shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise, from and after the earliest period allowed by law.

MEMORANDUM OF UNDERSTANDING

CUYAHOGA COUNTY

For the Use of Cuyahoga County's Mass Notification System, hereinafter referred to as "ReadyNotify"
This Memorandum of Understanding ("MOU") is made this day of, 20 ("effective date"), between the County of Cuyahoga ("County") , a County of the State of Ohio, through its Director of Public Safety and Justice Services, and, a municipality within
Cuyahoga County, through its authorized representative.
WHEREAS, ReadyNotify is a mass notification system used by Cuyahoga County and participating municipalities to issue notifications to the public and internal employees.
WHEREAS, ReadyNotify delivers messages to residents by telephone, cellular phone, text message, electronic mail, etc.
WHEREAS, ReadyNotify will be primarily used for emergency notifications, when prompt and accurate information is essential for immediate safety.
NOW, THEREFORE, the Parties understanding is as follows:
SECTION I. PROVISION OF SERVICES
The County is providing ReadyNotify to Cuyahoga County municipalities to assist in disseminating pertinent information regarding events within their jurisdictions.
The City/Village of has been granted access to the system which will provide them the ability to send notifications to their residents and internal employees.
Access to the Ready Notify system consists of the following provisions:
A. The County has assumed the costs associated with the ReadyNotify program, providing for the implementation, training and maintenance of the system.

- B. ReadyNotify is an unlimited service and does not contain any time usage restrictions.
- C. The County will provide training and technical support, as needed, to municipalities.
- D. The County, in conjunction with municipalities, will conduct an extensive public education campaign to promote ReadyNotify.
- E. Municipalities will designate one Point of Contact (POC) to manage ReadyNotify for their municipality.

- F. Usage of ReadyNotify will be determined by the municipality's operational needs, primarily addressing emergency and/or public safety issues, but ReadyNotify shall not be used for any political or commercial notifications.
- G. The County assumes no liability for messages sent on behalf of the authorizing Municipality. Any liability of the authorizing Municipality shall be determined based upon federal or Ohio law. This provision is not intended to create a special duty to any person or to create a third party beneficiary of this MOU.
- H. All alerts sent must abide by Federal, State, and County Policies/Laws
- I. The County maintains the right to remove any municipality's access to ReadyNotify if said municipality is deemed to be in violation of the above terms.

SECTION II. POINT OF CONTACT (POC)

The participating Municipality shall designate one (1) Point of Contact (POC) as the individual responsible for management of the ReadyNotify system for their municipality. The identified individual is also the POC for all communications between the Cuyahoga County Department of Public Safety and Justice Services, as set forth below:

INTRODUCED BY:

A RESOLUTION ESTABLISHING THE TELEPHONE REASSURANCE PROGRAM AND DECLARING AN EMERGENCY

WHEREAS, the Telephone Reassurance Program is an automated calling system that calls individuals who sign up for the service on a consistent, predetermined schedule to check on their well-being and to notify the Bratenahl Police Department if there is a potential problem; and

WHEREAS, the Telephone Reassurance Program will be administered by the Chagrin Valley Dispatch Council with cooperation from the Bratenahl Police Department.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Bratenahl, State of Ohio, that:

SECTION 1. The Council hereby establishes the Telephone Reassurance Program to be administered by the Chagrin Valley Dispatch Council, with cooperation from the Bratenahl Police Department, at an annual cost not to exceed three thousand, eight hundred seventy-five dollars (\$3,875.00), as shown on the estimate attached hereto as Exhibit "A".

SECTION 2. The Mayor is hereby directed to notify all Bratenahl residents of this opportunity to voluntarily enroll in said Telephone Reassurance Program and to obtain all the necessary information for a resident to participate in said Program. Such notification shall also include the resident's waiver of liability for the Village of Bratenahl, agreeing to hold the Village harmless against all claims, injuries and/or damages of whatsoever nature as a result of the Telephone Reassurance Program.

SECTION 3. Within sixty (60) days from the Mayor's notification to the residents as set forth in Section 2. above, the Village shall notify Chagrin Valley Dispatch Council of its desire to implement this Telephone Reassurance Program or to cancel its authorization herein. Chagrin Valley Dispatch Council shall have no obligation to proceed with said Program until it receives this notification.

SECTION 4. Council hereby appropriates sufficient funds to effectuate the provisions contained in Section 1 hereof, and the Village Fiscal Officer is hereby authorized to transfer the funds necessary to complete this expenditure from the available funds of the Village. The Village Fiscal Officer be and is hereby further authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Section 1 hereof, and is further directed to issue vouchers of this Village in the amounts and for the purposes as expressed in Section 1 hereof, said amounts to be charged to the appropriately designated Fund.

SECTION 5. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of the Village of
